

In the name of God Amen ~ I **EDWARD HENRY COLUMBINE** Captain of His Majesty's ship *Crocodile* being of sound mind do give and bequeath to **JOHN EDWARD DORRINGTON** Junior of Queen Square Westminster and **JAMES PILLINER** Stock Broker of Change Alley London and Mr **SAMUEL CURRY** of Gosport all the property of which I am possessed or to which I may be entitled here after In trust for the following purposes that is to dispose of all my property in the public funds until they can dispose of it in mortgages or good landed property the interest of the said money or such part of it as may be necessary for the education of my son **EDWARD HENRY COLUMBINE** to be retained by the said execs until my aforesaid son arrives at the age of twenty one years at which time the said property will be delivered over to him my said son **EDWARD HENRY COLUMBINE** for his sole use and benefit. In case my son **EDWARD HENRY COLUMBINE** should die before he comes of age and should not be married then the said property shall be divided into three equal parts that is for the use of one part to **SARAH DORRINGTON** the daughter of **JOHN DORRINGTON** the second part for the use of **JOHN EDWARD DORRINGTON** the elder son of **JOHN DORRINGTON** and the third part for the use of **JAMES DORRINGTON** the younger son of the said **JOHN DORRINGTON** and I leave the guardianship of my said son to my sister **SARAH DORRINGTON** and her husband **JOHN DORRINGTON**. The executors are to pay to the said guardians any sum that may be necessary for the maintenance and support of my said son **EDWARD HENRY COLUMBINE** during his childhood and I declare this to be my last Will and Testament annulling all former Wills (His signature) In witness whereof we attest to the signature this FIFTEENTH day of JUNE 1811 at Sea Latitude 34:24 North ~ Longitude [41 .hg No)

Codicil to my last Will and Testament I bequeath to Mr **SAMUEL CURRY** of Gosport my Bureau and black Dispatch Box and in case my son **EDWARD HENRY COLUMBINE** dying before his age to receive the property I have bequeathed to him it is my intention that all my books, plate, drawings, papers, instruments, swords and pistols shall not be separated but shall go to my nephew **JOHN EDWARD DORRINGTON** for his sole use given under my hand at Sea this 17th of JUNE 1811 (His signature) signed in the presence of us **JOHN FILMER 1st Lieut ~ W CURRY Parson ~ JAMES HIGGINS**

Proved at London 23rd AUGUST 1811 before the Worshipful **RICHARD HENRY CRESSWELL** Dr of Laws and surrogate by the oaths of **JOHN EDWARD DORRINGTON** the younger and **SAMUEL CURRY** two of the execs according to the terms of the said Will to whom Admon Exec granted being sworn duly to administer power reserved to **JAMES PILLINER** the other Exec
